There were 8 topics, 10 speakers, and 76 participants. Since then, the ACP in Southeast Washington has been holding annual CME courses, which have grown in members, fellows, and participation. Today, the annual Internal Medicine and Infectious Diseases What's New in Medicine CME program is a 501c3 organization.
