Program Development

Course Description/General Information:

The course objective is devoted to providing physicians, allied health practitioners and nurses with opportunities to advance their knowledge and increase their clinical skills through a continuing medical educational program. WRITTEN AGREEMENT FOR EXHIBITOR

As part of this commitment, the organization has outlined in this written agreement the terms, conditions, and purposes of commercial support for its CME activities. Commercial Support is defined as financial or in-kind, contributions given by a commercial interest, which is used to pay all or part of the costs of a CME activity. This agreement relates to the meeting "**What's New in Medicine 2023**," located at the 3 Rivers Convention Center, 7016 W. Grandridge Blvd., Kennewick, WA, on September 8 and 9, 2023.

Independence

1. This activity is for scientific and educational purposes only and will not promote any specific proprietary business interest of the Commercial Supporter.
2. The Accredited Provider (representative of **What's New in Medicine** planning committee) is responsible for all decisions regarding the identification of educational needs, determination of educational objectives, selection and presentation of content, selection of all persons and organizations that will be in a position to control the content of the CME, selection of education and the evaluation of the activity.
3. The Accredited Provider shall make all decisions regarding the disposition and disbursement of the funds from the exhibitors.
